Whereas DESIGN CADD TECHNOLOGIES and SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY shall be hereinafter jointly referred to as the "parties" and singularly as a "Party".

The Parties has decided to agree to establish industry –academic collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (MoU), SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY agree on following activities:

1. DESIGN CADD TECHNOLOGIES will provide training for students at SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY which would be relevant for industry.
2. Once a programme is designed and courses relevant to industry are offered at SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY, senior officials from DESIGN CADD TECHNOLOGIES will share their knowledge and experience by way of taking sessions, participating in seminars, workshops and other academic activities.
3. DESIGN CADD TECHNOLOGIES will offer internship, in-plant training to interested students of SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY at its offices / project –locations so that the students get hands on experience of live projects. The number of students, who can be considered for internship, would be as mutually decided between DESIGN CADD TECHNOLOGIES and SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY every year.
4. DESIGN CADD TECHNOLOGIES will arrange to provide field visits to students of SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY at its project sites to enable them to get practical exposure and learning from interaction with members of DESIGN CADD TECHNOLOGIES project-teams.

However, DESIGN CADD TECHNOLOGIES and SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY will ensure that all activities in progress are allowed to be completed successfully.
