CLAUSE 2 SCOPE OF THE MOU

- 2.5 Research and Development: Both Parties have agreed to carry out the joint research activities in the fields of Mechanical, Mechatronics and Robotics & Automation. First party and second party agree to make use of their respective facilities for the purpose of research and first party to ensure that the second party is acknowledged in the form of authorship in the research publications based on this work. Also, the interns/students to be involved in penning down case studies for the second party.
- **2.6** Skill Development Programs: Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- **2.7 Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in-house requirements.

CLAUSE 4 VALIDITY

- 4.1 The validity of the agreement is three years from the date of agreement.
- **4.2** Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **Sri Muthukumaran Institute of Technology** and **VM Tech Solutions and Management Services** are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
