MEMORANDUM OF UNDERSTANDING

### 1. Purpose of the AGREEMENT & MOU

8. Development of research/academic activities in key areas.

**3. Confidential and Proprietary Information**

1. "Confidential Information" shall mean all information, including the material and licenses or other information if any so given to SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by SUPREME COMPUTERS.
2. SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY shall hold in trust and confidence for information provided by SUPREME Computers and SRI MUTHUKUMARAN INSTITUTE OF TECHNOLOGY shall not disclose to any person or use such information for any purpose other than defined in this MOU.
3. The above confidential clause under this CONTRACT excludes the information/data possessed by either. Institute before entering this CONTRACT or independently developed and /or information already available through the public domain.



**4. Termination**

FIVE YEARS from the date of signing of MOU, unless renewed on a mutually agreed terms and condition for a further period. During the initial term or any renewal term, either party may terminate this MOU, after mutually agreed days, with prior written notice to the other party.





**5. Consequential Damages**

Other than explicitly mentioned in this MOU, either Party shall not under any circumstances or at any time be liable to the other under or in connection with the MOU for any special or any direct or indirect loss or damage or for any consequential loss or damage, whether direct or indirect, including but without limiting the generality of the foregoing, loss of profits, loss of production, or loss of opportunities.
